Following rule and regulations will be applied in the preparation and the conduct of the election:

- 1. Voting power will be given only to those who are members of the DMMUK.
- 2. Chairperson has been given power to conduct the election.
- 3. Ballot paper will be issued when more than one candidate is proposed for each office bearers post.

4. If there is more than one candidate for the same office bearers then the candidates will be invited to the floor individually to state their case for election to the office.

- 5. Where there is only one candidate, he/she will be elected.
- 6. If there is no candidate for an office bearer post then nominations will be invited from the floor (only for that post) and this must be on an official nomination form.
- 7. Any defeated candidate has the right to stand for a vacant office bearer post or a committee member, provided there is no other candidate previously proposed.
- 8. Scrutinisers will count the ballot paper and the chair will then announce and declare elected candidate for the post.

9. To ensure that a cross (X) is put against the name of the candidate of their own choice (if crosses are placed on more than one candidate then the ballot will be considered void.

10. If any candidate wishes to withdraw their nomination they should do so prior to the start of the election.

11. A candidate nominated for more than one post who is only elected for one of this post is deemed to have withdrawn from the second post.

12. If there are three candidates for any post, which results in a tie between candidates this, will result in a further ballot.

- 13. In the event of a tie between any of positions the Chair will have the casting Vote.
- 14. Qualification A paid member will have the right to stand for the office bearers post after serving as ordinary members of Community for one year.
